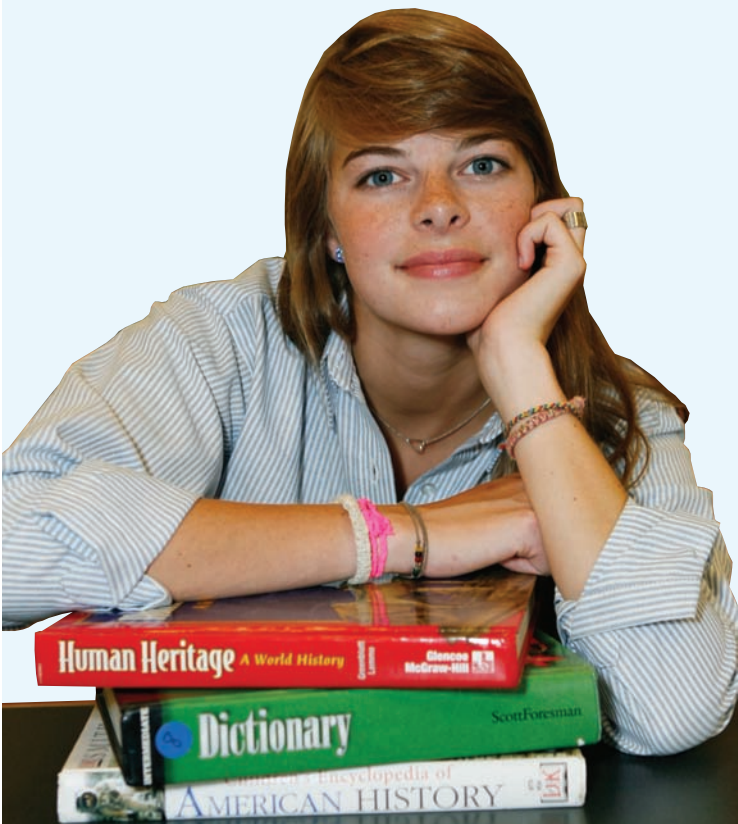


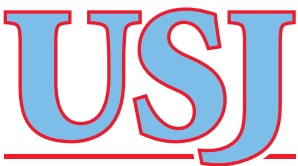

Cash or Check

Installment Gifts

Gift of Stock/Other Securities
